

Standards of Medical Examination for Executive Posts (Technical & Non-Technical), in NMRC:-

The candidate recommended for medical examination will have to pass medical fitness test(s) conducted by the NMRC Administration to ensure that the candidates are medically fit in all respects to carry out the duties connected with the post. Visual Acuity standard is one of the important criteria of medical fitness. Candidates are not eligible for any alternative appointment if they fail in the medical examination conducted by the NMRC before appointment for any reason. The medical standard for different categories are outlined below: -

1 . Executive /Technical	Civil/Electrical/Electronics (S&T)/Architecture/Property Development/I.T. etc.) Physically fit in all respects. Visual Standards – Distant Vision: 6/9-6/9 or 6/6-6/12 with or without glasses & Near Vision: J.I-J.II with or without glasses (power of lenses not to exceed \pm 4D), Colour Vision, Binocular Vision, Field of Vision & Night Vision should be normal.
2 . Executive / Non-Technical	(Accounts/Legal/Personnel etc.) Physically fit in all respects. Visual Standards – Distant Vision: 6/9-6/12 with or without glasses & Near Vision: J.I-J.II with or without glasses.

Note: - The above medical standards (criteria) are indicative and not exhaustive, and apply to candidates in general. For detailed information, refer Indian Railway Medical Manual (IRMM).**Candidates may note that for vision correction, lasik surgery or any form of radical keratomy is not permitted at all.**

Standards of Medical Examination in NMRC (For Non Executive Post)

The candidate recommended for medical examination will have to pass medical fitness test(s) conducted by the NMRC Administration to ensure that the candidates are medically fit in all respects to carry out the duties connected with the post. Visual acuity standard is one of the important criteria of medical fitness of NMRC staff. Candidates are not eligible for any alternative appointment if they fail in the medical examination conducted by the NMRC before appointment; for any reason. The medical standard for different categories are outlined below:-

- **A-1**
Physically fit in all respects. Visual Standards - Distance Vision: 6/6, 6/6 without glasses/contact lens. Near Vision: Sn: 0.6, 0.6 without glasses/ contact lens (must clear fogging test). Colour Vision, Binocular Vision, Field of Vision & Night Vision must be present.
- **A-2**
Physically fit in all respects. Visual Standards - Distance Vision: 6/9, 6/9 without glasses/ contact lens. Near Vision: Sn: 0.6, 0.6 without glasses/ contact lens. Colour Vision, Binocular Vision, Field of Vision & Night Vision must be present.
- **A-3**
Physically fit in all respects. Visual Standards - Distance Vision: 6/9, 6/9 with or without glasses. Near Vision: Sn: 0.6, 0.6 with or without glasses. Colour Vision, Binocular Vision, Field of Vision & Night Vision must be present.
- **B-1**
Physically fit in all respects. Visual Standards - Distance Vision: 6/9, 6/12 with or without glasses (power not to exceed \pm 4D). Near Vision: Sn: 0.6, 0.6 with or without glasses when reading or close work is required. Colour Vision, Binocular Vision & Night Vision must be present.
- **B-2**
Physically fit in all respects. Visual Standards - Distance Vision: 6/9, 6/12 with or without glasses (power not to exceed \pm 4D). Near Vision: Sn: 0.6, 0.6 with or without glasses when reading or close work is required. Colour Vision, Binocular Vision & Night Vision must be present.
- **C-1**
Physically fit in all respects. Visual Standards - Distance Vision: 6/12, 6/18 with or without glasses. Near Vision: Sn: 0.6, 0.6 with or without glasses when reading or close work is required.
- **C-2**
Physically fit in all respects. Visual Standards - Distance Vision: 6/12, Nil with or without glasses. Near Vision: Sn: 0.6 combined with or without glasses when reading or close work is required.

Note: The above medical standards (criteria) are indicative and not exhaustive, and apply to candidates in general.
