15	<p>Minimum Eligibility Criteria:</p>	<p>The Bidder's competence and capability is proposed to be established by the following parameters. The Bidder should meet all the criteria given in this section.</p> <p>a) Sole proprietorship, registered partnership firm (incl LLP), public limited company, private limited company of any of the above can submit the Bid. The firms and the companies should be registered in India.</p> <p>b) The Bidder should have completed in India during last 7 (Seven) years period ending last day of month previous to the one in which the bids are invited should be either of the following:</p> <p>i. One similar completed work costing not less than the amount equal to Rs. 18.44 Lakh (Rupees Eighteen Lakh Forty Four Thousand only) or</p> <p>ii. Two similar completed works each costing not less than the amount equal to Rs. 11.53 Lakh (Rupees Eleven Lakh Fifty Three Thousand only) or</p> <p>iii. Three similar completed works each costing not less than the amount equal to Rs. 9.22 Lakh (Rupees Nine Lakh Twenty Two Thousand only).</p> <p>Definition of Similar Work: "Supply of Consumables and Tools in any Central Govt./State Govt./PSU's or any Private Limited Company of repute."</p> <p>c) The Bidder should have minimum Average Annual Turnover of Rs. 23.05 Lakh (Rupees Twenty Three Lakh Five Thousand Only) in the last 3 (three) Financial Years (2022-2023, 2023-2024, 2024-2025) preceding the Bid Due Date.</p> <p>d) The Bidder should not have been blacklisted/ banned/ declared ineligible for corrupt and fraudulent practices by the Government of India/ any State Government/ Government Agency and Supreme court and contracts have been terminated/ foreclosed by any company / department due to non-fulfillment of Contractual obligation in last 5 (five) financial years.</p> <p>e) The Bidder should be registered with the Goods and Services Tax Authority.</p> <p>f) The Profit before tax of bidder during any of the financial year should be positive during immediately preceding 3 Audited Financial years (2022-23, 2023-24, 2024-25).</p> <p>Note: Bidders are required to go through the website http://etender.up.nic.in for submitting the e-bid.</p>

Note:

1. Tender Cost and Tender Security (EMD) is exempted for Micro & Small Enterprises (MSEs) registered with District Industries Centre or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Dte. Of Handicraft & Handloom or any other bodies specified by Ministry of Micro, Small & Medium Enterprises for appropriate category and have valid registration certificate as on date of tender submission. Only those MSEs will be eligible for Tender cost and Tender Security exemption which are registered under following category or closely related category (with valid registration):-

“Supply of Consumables and Tools for Rolling Stock Department.”

2. The tenderers seeking exemption from Tender Cost and Tender Security', being MSEs, shall ensure their eligibility w.r.t above and submit registration certificate issued by the body under which they are registered which clearly mentions category of along with Terminal Validity of registration.
3. In absence of any of the above requirements no exemption for 'Tender cost and Tender security will be allowed and their bid will be rejected and not evaluated further without the Tender cost and EMD.
4. No further clarification shall be sought on the above.
5. In case the bidder who has been exempted Tender Cost/Tender Security being Micro & Small Enterprise, and;
 - (i) Withdraws his Tender during the period of Tender validity; or
 - (ii) Becomes the successful bidder, but fails to commence the work (for whatsoever reasons) as per terms & conditions of Tender; or
 - (iii) Refuses or neglects to execute the contract; or
 - (iv) Fails to furnish the required Performance Security within the specified time
6. The bidder shall be debarred from participating in future tenders for a period of 1 year from the date of discharge of tender/date of cancellation of NOA/annulment of award of contract as the case may be. Thereafter, on expiry of period of debarment, the bidder may be permitted to participate in the procurement process only on submission of required Tender Cost/ Tender Security.

Further the Employer may advise the authority responsible for issuing the exemption certificate to take suitable actions against the bidder such as cancellation of enlistment certificate etc.
