1.1 GENERAL

1.1.1 Noida Metro Rail Corporation Ltd. invites open e-tender through e-tendering system (i.e. Technical and Financial bid) from eligible applicants who fulfill qualification criteria as stipulated in NIT/RFP for “**Supply of OHE Span Dropper Components**”.

1.2 Minimum Eligibility Criteria:

The Bidder's competence and capability is proposed to be established by the following parameters. The Bidder should meet all the criteria given in this section:

- a) Sole proprietorship, registered partnership firm (including LLP), public limited company, private limited company can submit the Bid. The firms and the companies should be registered in India.
- b) The Bidder should have completed in India during last 7 (Seven) years period ending last day of month previous to the one in which the bids are invited should be either of the following:
 - i. One order of similar nature of value not less than Rs. 45.27 lakh (Rupees Forty Five Lakh Twenty Seven Thousand only) or
 - ii. Two orders of similar nature of value not less than Rs 28.29 lakh (Rupees Twenty Eight Lakh Twenty Nine Thousand Only) each or
 - iii. Three orders of similar nature of value not less than Rs 22.63 lakh (Rupees Twenty Two Lakh Sixty Three Thousand Only) each.

Definition of Similar Work: Works involving supply/manufacturing of high voltage electrical equipments in Railways or Metro Rail Projects, Government organization/PSUs.

- c) OEM of Bidders (either themselves or through resellers) should have metro/railway experience for supply of Span Dropper components or should be RDSO approved for OHE (25 KV) category.
- d) Bidders are required to enclose copies of the work orders and work completion certificate in support of the same with the Technical-Bid. Work completion certificate should clearly indicate the nature/scope of work, actual completion cost and actual date of completion for such work. Without proper and valid certificates from the Employers, bid will be rejected.
- e) The Bidder should have minimum average annual turnover Rs. 56.58 Lakh (Rupees Fifty Six Lakh Fifty Eight Thousand only) in the last 3 (three) audited Financial Years (2022-23, 2023-24, 2024-25) preceding the Bid Due Date.
- f) Profit before tax should be positive in atleast 1 (one) year; out of the last 3 (three) audited financial years ending on 31st March, 2025.
- g) NMRC/any other Metro Organization (100% owned by Govt.) / Ministry of Housing & Urban Affairs / Order of Ministry of Commerce, applicable for all Ministries must not have banned business with the tenderer (including any member in case of JV/consortium) as on the date of Bid submission for Supply of OHE Span Dropper Components. The tenderer should submit undertaking to this effect in Form-7 of Tender.
- h) Bidders are required to provide the self attested copy of NIT & RFP.
- i) The Bidder should be registered with the Goods and Services Tax Authority.
- j) Bidders are required to provide the Technical Data Sheet.
- k) Material shall be accepted after satisfactory performance during FAT & submission of type test reports.
- l) The successful bidder shall submit design document of dropper assembly for approval of engineer in charge prior to manufacturing.
